Welcome! If you have never joined IFOA previously, we welcome you on your first step to membership and officiating high school football! If you are a current or previous member, please use the standard Membership Application Form.

Officiating football is fun and challenging. One should be able to move rapidly otherwise known as “hustle” while at the same time, not hurrying! There is also a risk of injury not only to players but to officials as well. As such, an official may be accused of negligence and is subject to litigation. Due to this risk Sports Officiating Liability insurance is a requirement of membership. IFOA has negotiated a deal with National Association of Sports Officials (NASO) to provide up to two million dollars for Sports Officiating Liability insurance and that premium includes other benefits such as a one-year subscription to Referee Magazine. NASO Sports Officiating Liability Insurance covers all sports and if purchased through IFOA the period of coverage is August 1, through July 31 of the calendar year*.

Each member of IFOA is an Independent Contractor. Any member may accept/decline game assignments. IFOA Membership includes: Training, training materials and meeting locations and facilities. Game assignments are handled by the Contracted Assigner of IFOA and a separate fee is made payable to this person as noted below. Include both payments and both forms with your IFOA membership submittal.
